

**COOPERATION AGREEMENT**  
**between**  
**JSC “S.Seifullin Kazakh Agrotechnical University”**  
**(Republic of Kazakhstan) and**  
**National Technical University of Ukraine**  
**“Igor Sikorsky Kyiv Polytechnic Institute”**

---

In order to establish direct and mutually beneficial cooperation in the field of higher education, science and culture and to increase the effectiveness of educational, methodological and scientific research work, the **JSC “S.Seifullin Kazakh Agrotechnical University”**, represented by its Chairman of the Board **Kurishbayev Akhymbek**, acting under the Regulations on the one part, and National Technical University of Ukraine “Igor Sikorsky Kyiv Polytechnic Institute”, represented by its First Vice-rector **Jakymenko Yuri Ivanovych** acting under the Letter of attorney №1 from 29.01.2018 on the other part, jointly referred to as the “Parties” and individually as a “Party”, have entered into this Cooperation Agreement (hereinafter the “Agreement”) as follows:

---

**Article 1**

The purpose of this Agreement is cooperation between Universities in the field of «Biotechnology» in academic and research directions, as well as exchanges of teachers and students. From the Party of Igor Sikorsky Kyiv Polytechnic Institute such collaboration will provide by the Department of Industrial Biotechnology the Faculty of Biotechnology and Biotechnic, from the Party of JSC “S.Seifullin Kazakh Agrotechnical University” – by the Department of Microbiology and Biotechnology of the Faculty of Veterinary Sciences and Animal Husbandry and Research Platform of Agricultural Biotechnology.

**Article 2**

With the intention of implementing the goals of this Agreement, the Parties have generally agreed to co-operate in the following areas:

- academic exchanges of teachers, researchers, PhD students, graduate and undergraduate students for the purposes of education, long-term and short-term internship, educational-scientific practices and training, professional (educational-manufacturing, manufacturing, research, pregraduation and pedagogical) practices;
- cooperation in the training of highly qualified educational and scientific staff and specialists in the fields of mutual interest;
- cooperation in the field of joint educational dual-degree programs at the level of undergraduate and graduate programs with the issue of Diploma certificates of the

Parties;

- invitation of the representatives of the Parties to read lectures, exchange of experience and information in the educational, methodological work and exchange of educational projects and programs;
- organizing and conducting on-line lectures by professors and administrative staff of the Parties;
- organization of joint scientific and scientific-technological researches, including, but, without being limited, with engagement of professors for co-management and scientific consultation in the writing of master's and doctoral theses;
- organization of scientific and scientific-technical joint research, conferences, seminars, symposia, round tables, days which are devoted to the Parties, and other similar scientific actions and initiatives in the field of education and science. The results of such activities can include publications in peer-reviewed scientific journals from the world's leading databases of Science Citation, including Web of Science, Scopus, and others;
- creating and publication of joint scientific and educational works as the result of implementation of joint activities;
- exchanges of publications, scientific research, educational and methodological literature, periodicals and information about ongoing activities;

The terms of the activities defined in the Article 2 will be determined by separate agreements between the Parties.

### **Article 3**

The cost and expenses to be paid in relation to any co-operation or collaboration envisaged under this Agreement shall be subject to further detail arrangements to be agreed between the Parties as and when it shall arise.

The Parties consider attracting potential financial partners, including funds is possible.

### **Article 4**

This Agreement may be amended or modified by a written additional agreement, which will be an undivided part of the Agreement which must be properly registered and signed by the representatives of two universities.

### **Article 5**

Both universities agree to carry out these activities in accordance with the laws and regulations of the respective countries.

Disputes, arising in accordance with the Agreement will be resolved by consultation and conversation between Parties.

## Article 6

This Agreement enters into validity and effect on the day of its signing by the statutory representatives of the Parties. It shall be effective for a period of 5 (five) years and automatically prolonged for the next 5 (five) years unless it is terminated by one of the universities upon prior notice to the other in writing not later than 6 (six) months before the termination date.

## Article 7

This Agreement is prepared in English in two copies, one for each Party, both having the same legal force.
